2)	Two recent passport size coloured photographs (full face on white background , one photo attached to application)			
3)	Current Passport and Previous passports (if any) <ul style="list-style-type: none"> • passport shall contain two blank pages • current passport shall be valid for a period of 90 days beyond the date of return to Sri Lanka • previous passports should be submitted at the interview • lost passports should be declared with a police report (translated into english and certified by the Consular Division - Ministry of Foreign Affairs Colombo) • photocopy of passport bio-page and any amendments 			
4)	Medical/health documentation comprised of - <ul style="list-style-type: none"> • Medical documentation issued by the country of residence attesting to applicant's health issue • Medical report issued by the Embassy doctor Dr. Dr. A.M. SEBASTIAMPILLAI (no. 166/12 Kirulapone Avenue, Colombo 05 – Tel: 2514104 / 0777 845674) • Declaration by a public or private Italian health care facility (this letter must to accredited by the national health service - A.S.L.) indicating type of treatment, date initiated, estimated duration and costs • Document from the Italian healthcare facility confirming the deposit of at least 30% of the estimated costs of the treatment requested or alternatively a specific administrative act passed by an Italian Region or specific authorisation issued by the Ministry of Health within the framework of humanitarian programmes 			
5)	Financial Status - <ul style="list-style-type: none"> • Documentation proving the availability of resources sufficient for payment of remaining healthcare expenses, food and lodging outside the healthcare facility and repatriation of the patient • personal bank accounts (current / savings / fixed deposit etc) for last 3 months • certified valuations for movable and immovable assets • letter from Bank stating the issuance of foreign exchange on receipt of visa • most recent credit card statement • letter from employer / salary slips for last 3 months 			
6)	Sponsorship by a 3rd person (Italian nationals / Foreigners legally residing in the country) – for medical care to the costs assumed by a third person it's necessary that the sponsor provide documentary evidence of his/her ability to meet the financial requirements of the patient and any accompanying persons			
7)	Board and Lodging – documentation supporting available means for food,board and lodging outside the healthcare facility in case it's not provided by sponsoring party or hospital			
8)	Insurance - travel, medical and accident insurance policy as per travel itinerary - cover of Euros 30,000/-			
9)	Airline Ticket – confirmed reservation issued by airline or travel agency			
10)	Proof of Previous Travel - photocopies of visas issued in the last two years by Schengen countries, UK, Ireland, USA, Canada,Australia and New Zealand

- All documents should be provided in original accompanied with a set of photocopies in A4 size
- Documents in Sinhalese, Tamil or any other language must be presented with an official English or Italian translation and certified by the Consular division Ministry of Foreign Affairs Colombo or in case of non-Sri Lankan nationals certified by the respective Embassy / High Commission / Consulate based in Colombo
